

UltraMED 2018 MIPS Solution Summary

Step 1: Choose 6 quality measures that apply to your practice specialty from the list following this page.

Step 2: We will help you to create your tracking worksheet, where you easily record for each visit. The worksheet should be sufficient evidence if an audit occurs.

Step 3: You quickly go through the worksheet with each patients to enter their default measure choices into an UltraMED entry screen that will pop up for the patient's first 2018 visit.

Step 4: During any patient's subsequent visits in 2018, you only have to invoke that entry screen if there are changes for that patient (usually not).

Step 5: Sign up the Plus registry module at www.healthmonix.com (select Solutions, MIPS Registry, Pricing, 2018, Purchase – under Plus. Use discount code “ultramed” to pay \$450 per provider instead of \$499)

We shall then submit your visit information along with your recorded quality measure choices to Healthmonix multiple times during 2018, so that we can keep monitoring your MIPS score before Healthmonix finally submits on your practice's behalf to the registry at the beginning of 2019 -- after you have finished entering all your 2018 claim data. UltraMED's fee will be 0.5% of your Medicare income in 2017, with a minimum of \$500 and a maximum of \$3000 per UltraMED office regardless of the number of providers.
